**LIABILITY WAIVER**

**ASSUMPTION OF RISK AND RELEASE OF LIABILITY**

Date: Friday, November 16, 2007

U.S. Department of Justice – 950 Pennsylvania Ave., N.W. Washington, D.C.

In consideration of me being allowed to participate in the NAACP going to the United States Department of Justice for the 'Rally on the Justice Department', which includes attendance at, and transportation to and from the event, I agree, if I am 18 years or older, or I hereby authorize my child if she or he is under 18 years of age that:

I \_\_\_\_\_, hereby execute this Waiver as to the National Association for the Advancement of Colored People (NAACP), any and all Maryland Branches, Maryland State Conference of NAACP Branches, the National NAACP, and any of its affiliates, freely and voluntarily and hereby agree to participate in the Rally at the United States Department of Justice on November 16, 2007 subject to the following conditions. I understand the dangers that may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity and the conditions under which the Activity is conducted. I understand the nature of the Activity and acknowledge that I am qualified to participate in such Activity. I further acknowledge that I am aware that the Activity will be conducted in facilities open to the public during the Activity. I further agree and warrant that, if at any time, I believe conditions to be unsafe; I will immediately discontinue further participation in the Activity.

2. I FULLY UNDERSTAND that: (a) attending this March may involve risks and I HEREBY RELEASE, DISCHARGE, COVENANT NOT TO SUE AND AGREE TO HOLD HARMLESS the officers, members and organizers of this event, members, directors, agents, officers, volunteers and employees, local organizing committees, other participants, any other sponsors, from all liability, claims, demands, losses, damages or expenses on account caused or alleged in whole or in part by any act or omission of any one or more of the Released Parties in connection with the baseball game.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and voluntarily without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid that the balance, notwithstanding, shall continue in full force and effect.
